Occupational English Test (OET) is an international English language test used in the healthcare Sector for healthcare professionals. It evaluates the communication skills of healthcare professionals who wish to register and practice in an English-speaking environment.

OET is a well-respected test established under the Australian Federal Government in the late 1980s. Cambridge Boxhill Language Assessment, a project between Cambridge Assessment English and Box Hill Institute own OET since 2013.

New Zealand accepted OET for registration purposes in 2013. Immigration New Zealand also accept OET results for all categories of visa which have an English requirement attached to them. On top of this, your OET results will gain you entry into a number of courses by leading universities and education providers.

Overseas-trained nurses and midwives need to take an English language test to gain registration with the NMC. The UK's Nursing and Midwifery Council (NMC) recognized OET for registration from 1 November 2017.

To work as a health practitioner in Australia, you need to apply for and be registered with the relevant national board.

All National Boards have a registration standard for English language skills which require applicants for initial registration to demonstrate English language skills to be suitable for registration. OET is accepted by most National Boards.

Steps for nursing registration to Australia



First Generation provides help to ensure you the title of Registered Nurse in Australia. If you are a nurse (B.Sc or M.Sc diploma), we assist you throughout the process so that you don't face any confusion and get your registration smoothly.

A partial license /decision letter would be issued once you get through the adaptation program. The candidate has to fill the formats along with the supporting documents and the assessment is done by AHPRA (The Australian Health Practitioner's Regulatory Authority). Once the registration of the Nursing professionals is done, the nurses may be eligible to apply for a PR status (Permanent Residency) and the candidate would travel on a work visa sponsored by the employer (the hospital).

AHPRA and Bridging Program Australian Health

Practitioner Regulation Agency (AHPRA) has a registration standard for all applicants for the initial registration. We help our students to meet these standards through OET and register as professional health practitioners.

We assist the students to get enrolled in the bridging programs run by AHPRA for overseas nurses known as Initial Registration for Overseas Nurses (IRON) program. The program is aimed to enhance nursing skills of current and qualified health professionals to adhere to Australian standards.

Registered Doctor in UK and Australia

For any doctor from a non-British speaking country wanting to work in the UK, it is required by the General Medical Council (GMC) that you pass an English language exam. Since February 2018, the Occupational English Test (OET) has been accepted for registration in the UK.

OET was created in Australia and is accepted as a test for registration if you are a doctor. The bulk of the test is made up of medical language and terminology, it is considered much easier for doctors who are experts in their field to pass.



Working visa to UK

The UK Government has relaxed its immigration rules surrounding doctors and nurses from outside the EU.

Healthcare professionals from non-EU countries will be excluded from the government's limit on skilled migration. The change could lead to a greater number of international doctors and nurses filling NHS vacancies in the short-term future.

In the UK, employers use Tier 2 visas to bring in skilled workers, including doctors, nurses and other healthcare professionals, from outside the EU. There will be no restriction on the number of doctors and nurses that can be hired through the Tier 2 visa route.

The test is recognized by both the Nursing and Midwifery Council (NMC) and the General Medical Council (GMC) to measure English language and communication skills.
